### **PRODUCT NAME: STRIPE- X REMOVER.**

**PRODUCT DESCRIPTION:** **STRIPE-X Remover** is a specially formulated water-based, safe liquid mixture to be applied on already cured STRIPE-X coatings. The chemistry is so designed to activate and dissolve the STRIPE-X coating so it can be lifted / separated from the substrate and washed away / removed.

Unique to USSC, for ease of application, it also packaged in aerosol cans.

**PRODUCT FEATURES:** STRIPE-X is water-based and does not contain harmful flammable solvents. It is relatively non-toxic to the applicator and to the environment. As with any chemicals, adequate hygiene and precautions have to be taken during storage, use and disposal of this product.

**RECOMMENDED USES:** For use on all interior and exterior surfaces, namely Asphalt, Concrete, and indoor and outdoor **Synthetic Field Turf Athletic Fields** of all filament types to remove existing STRIPE-X paint.

**SURFACE PREPARATION:** Temperature during application, soaking, scrubbing and rinsing must be above 50 degrees Fahrenheit or the removal process will be slow and sluggish.

### **APPLICATION PROCEDURE:**

**Brush:** A good quality synthetic or nylon brush.

**Roller:** Can be applied with all kinds of Rollers. Long nap rollers are Recommended.

**Spray:** Can be applied with all Airless and Conventional spray equipment. Pump-up Garden sprayers or pull behind boom sprayers.

**CONTAINER:** 5 gallon buckets with silk screen imprint. Lids with tear away tabs and must be resealable.

**FREEZE-THAW:** Avoid freezing.

**SHELF LIFE:** 2+ years.

**REMOVING PROCEDURE:** Spray the STRIPE-X REMOVER over the STRIPE-X COATING that needs to be removed. Let remover soak for 5 minutes. Next, scrub with stiff bristle brush or power scrubber or use gentle pressure washing. Rinse loose paint and remover mixture with water and the STRIPE-X coating will be completely washed away / removed. For stubborn or baked on coating that has been on turf for a awhile, just repeat this procedure. The wash off is non-toxic and the run off is safe to dispose in the sewer system.
